**Rowan Pruitt** – Federal Mediation & Conciliation Service (D.C.)



## DRAFTING FOR PUBLIC POLICY COURSE BRINGS TEXAS POLICY LEADERS TO THE LAW SCHOOL

Professor Tom Krampitz Brings Policy & Policymakers to the Classroom

Texas A&M School of Law recognizes the importance of communication in the legal and policymaking spaces. For example, it requires students to take a

minimum of three semesters of legal writing, including unique upper-level courses that focus on specific drafting and communication techniques that law students might not experience otherwise. One of these courses is Drafting for Public Policy that is designed to introduce students to the various types of communications (both oral and written) that they might encounter in the public sector such as, hearing testimony, "one pagers," briefing documents, and pitch memoranda. This highly specialized course is a prerequisite for students participating in the Residency Externship Program in Public Policy.



In Fall 2021, the course was taught by adjunct professor, Tom Krampitz.

Professor Krampitz is a leader in Texas

state and local policy. His breadth of experience was evident in the guest speakers he brought into the Drafting for Public Policy course. In just 12 short weeks, Professor Krampitz introduced his students to the following Texas policy leaders—
