

# Texas A&M Law Review to host Fall Symposium focused on Agriculture, Intellectual Property, and Feeding the World in the 21<sup>st</sup> Century

Fort Worth, TX, September 29, 2016 – For its Fall 2016 Symposium, *Texas A&M Law Review* will host Agriculture, Intellectual Property, and Feeding the World in the 21<sup>st</sup> Century on October 28, 2016.
